NOTICE is hereby given that the 83rd Annual General Meeting ('AGM') of the members of Modi Industries Limited will be held on Thursday, the 21st December, 2017, at 12:30 P.M., at Modi Industries Transit House (Modi Industries Complex), Modinagar, U.P., to transact the Ordinary and Special Business, as set out in the Notice of AGM. The physical copy of the Notice of the Meeting, Annual Report for the financial year ended March 31, 2017 and remote e-voting details have been sent to all members individually at their registered addresses. The date of completion of dispatch of the notices to the shareholders is 27th November, 2017. These documents are also available on Company's website www.modiindustriest.net for download by the members and kept at the Registered Office of the Company for inspection by Members.

Notice is hereby given in compliance with the provisions of Section 108 of the Companies Act, 2013 read with the Companies (Management and Administration) Rules, 2014 as amended that the Company has offered e-voting facility for transacting all the business through National Securities Depository Ltd. (NSDL) through their portal www.evoting.nsd.com to enable the members to cast their votes electronically. The remote e-voting period commences on Monday, the 18th December, 2017 (09:00 am) and ends on Wednesday, the 20th December, 2017 (05:00 pm). No e-voting shall be allowed beyond the said date and time. During this period members of the Company, holding shares, as on the cut-off date of 14th December, 2017, may cast their vote by remote e-voting. Any person, who acquires shares and becomes member of the Company after dispatch of the notice and holding shares as on the cut-off date i.e. 14th December, 2017, will be provided the notice through mail or by post after the cut-off date and such members may also obtain the login ID and password by sending a request at evoting@nsdl.co.in or RTA, MAS Services Limited. However, if the members are already registered with NSDL for remote e-voting then they can use their existing user ID and password for casting their vote. The remote e-voting module shall be disabled by NSDL for voting thereafter. Once the vote on a resolution is cast by the member, the member shall not be allowed to change it subsequently. The facility for voting through ballot paper shall be made available at the AGM and the members who have cast their vote by remote e-voting prior to the AGM may also attend the AGM but shall not be entitled to cast their vote again. Shri Amar Nath Jaiswal, the Proprietor shall act as scrutinizer on behalf of M/s. A.N. Jaiswal & Co., (Membership No. ACS-19000 & CP No. 14629) of New Delhi appointed as Scrutinizer for the e-voting process.
